Dr. Bondurant led the discussion on the 2024 budget recommendations. He presented a brief overview of the budget that was submitted to the finance committee.

Board member Dorothy Adams asked clarifying questions about salaries, merit increases, and the cost of living, to which Dr. Bondurant and Jennifer Morrill responded.

Dr. Bondurant stated that they would like to see the time-limited Sustainability Analyst position moved to full-time benefited position, an increase in travel and training, and an increase in commodities. He gave major kudos to the staff for keeping the budget and the request for tax dollars to a minimum.

Board members provided comments and asked follow-up questions, which Dr. Bondurant answered.

Chair Cherniak raised the question of the next steps regarding the budget. Dr. Bondurant responded.
